

**Requests for Reinstatement to the University  
College of Liberal & Fine Arts**

***I've been academically dismissed from UTSA for the first time ever. What if I want to come right back and not fulfill the requirements of my first academic dismissal?***

**You have the right to appeal your dismissal, but early reinstatements are very rare.** In order to be considered for early reinstatement, you must submit a packet of information (listed below) that presents a compelling argument for this exception to University policy. All the documentation listed below must be provided in order for your request to be considered. Incomplete information will result in your request not being considered. **REMEMBER THIS IS FOR FIRST TIME DISMISSALS ONLY**

1. Completed Waiver of University Requirements for Dismissal.
2. Typed or handwritten letter (maximum of 1 page) in which you explain your circumstances. The circumstances should be extenuating, temporary and must be documented.
3. Any documentation to verify your circumstances and/or strengthen your appeal should be attached to your application. Packets will not be returned to you, so do not include the original copy of documents you will need for your files. Xerox copies are acceptable.

**COMPLETED packets for appeals for first time dismissals must be submitted to the Office of the Dean, COLFA, HSS 4.01.23. by the appropriate deadline:**

October 1	Spring Semester
March 1	Summer Semester
June 1	Fall Semester

**In addition, paperwork may NOT be faxed, emailed or mailed via USPS. All paperwork must be submitted in person by the appropriate deadline for consideration.**

**Please note that should you be reinstated, the offer of reinstatement is only good for the semester granted. Should you not attend, you must follow the procedure listed at the top of this page, including submitting your application for admission and reinstatement fee by the University application deadlines.**

When the COLFA Reinstatement Committee has reached a decision you will be notified in writing. Due to the large volume of requests for reinstatement, please do not contact the Office of the Dean, as this confidential information **will not** be released over the phone.

**You have the right to appeal your dismissal, but early reinstatements are very rare. You may be considered for only one semester early reinstatement, after you have not attended UTSA for at least two long semesters.** In order to be considered for early reinstatement, you must submit a packet of information (listed below) that presents a compelling argument for this exception to University policy. All the documentation listed below must be provided in order for your request to be considered. Incomplete information will result in your request not being considered. **REMEMBER THIS IS ONLY AFTER YOU HAVE SET OUT AT LEAST TWO LONG SEMESTERS. This is for 2 or more dismissals, counting the one you just received.**

1. Completed Petition for Reinstatement
2. Completed Waiver of University Requirements for Dismissal.
3. Typed or handwritten letter (maximum of 1 page) in which you explain your circumstances. The circumstances should be extenuating, temporary and must be documented.
4. Any documentation to verify your circumstances and/or strengthen your appeal should be attached to your application. Packets will not be returned to you, so do not include the original copy of documents you will need for your files. Xerox copies are acceptable.
5. **Official Transcript(s) for all courses taken at another institution since leaving UTSA.**

**COMPLETED packets must be submitted to the Office of the Dean, COLFA, HSS 4.01.23. by the appropriate deadline:**

October 1	Spring Semester
March 1	Summer Semester
June 1	Fall Semester

**In addition, paperwork may NOT be faxed, emailed or mailed via USPS. All paperwork must be submitted in person by the appropriate deadline for consideration.**

**Please note that should you be reinstated, the offer of reinstatement is only good for the semester granted. Should you not attend, you must repeat the reinstatement process and meet all the above requirements, including your application for admission and payment of reapplication fee.**

When the COLFA Reinstatement Committee has reached a decision you will be notified in writing. Due to the large volume of requests for reinstatement, please do not contact the Office of the Associate Dean, as this confidential information **will not** be released over the phone.
