### **DEMOCRATIC SUPPORT SURGES IN BEXAR COUNTY WITH HARRIS ON THE BALLOT; MIXED SUPPORT FOR CITY CHARTER AMENDMENTS AND NEW PRO SPORTS FACILITIES; NO EARLY LEADER IN 2025 SAN ANTONIO MAYORAL RACE**

RESULTS FROM BEXAR COUNTY VOTER POLL—SEPTEMBER 11-16, 2024

#### **Executive Summary**

**SAN ANTONIO, TX** – The UTSA Center for Public Opinion Research’s (CPOR) latest Bexar County Voter poll (n=692) shows a surge in support for Democratic candidates in the county following Kamala Harris winning the Democratic nomination. Harris finds herself in a much stronger position than Joe Biden was [in CPOR’s June poll](#) among Bexar County voters, with down-ballot Democrats also seeing their standing improved (Part 1).

Most San Antonio voters (more than 8 in 10) continue to be unfamiliar with the proposed amendments to the San Antonio City Charter that will appear on the ballot this November (n=620). When asked about their support for each of the six amendments, only two (updates to the Ethics Review Board and the replacement of outdated language in the charter) received majority support. Only 1 in 6 San Antonio voters said they supported an amendment that would remove caps on the salary and term length of the city manager (Part 2).

The poll also asked San Antonio voters about their plans to vote in the 2025 San Antonio municipal elections. Among those who planned to vote in these elections (n=569), there was no clear front-runner in the open-seat mayoral race, with nearly 70 percent of voters saying they were unfamiliar with the candidates or did not know how they would vote. Among all Bexar County voters, there was limited support for plans for news sports facilities for the San Antonio Spurs basketball team and San Antonio Missions minor league baseball team (Part 3).

Bexar County voters continue to give relatively high marks to local government and local officials (Mayor Ron Nirenberg and Bexar County Judge Peter Sakai), mixed marks to the state government, and low marks for the federal government. Both Governor Abbott and President Biden had low approval ratings. Bexar County voters are more optimistic about the direction the city is going in than they are about the state and country (Part 3).

The study’s methodology is included in Part 4, and question wording and tabulations are included in the appendix.

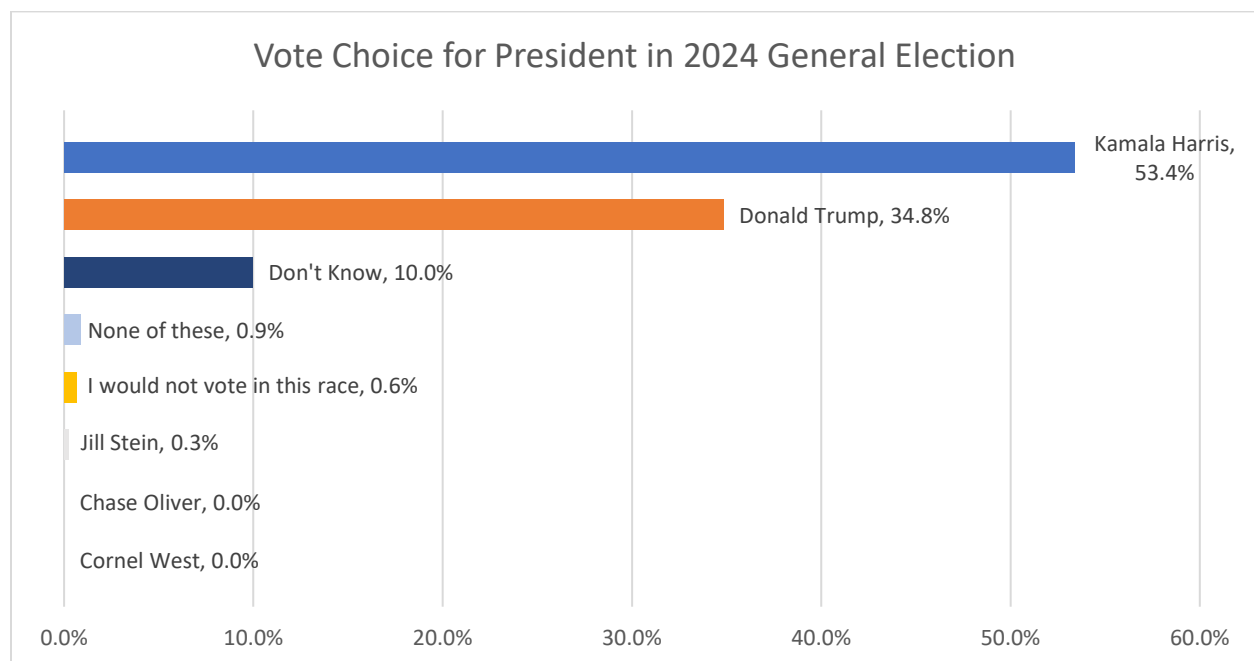

### Part 1. Vote Choice in November General Elections

Support for the Democratic nominee for president surged among Bexar County voters who planned to vote in November (n=673) compared to [CPOR's last voter poll in June](#), when Joe Biden was still the presumed nominee. Whereas Biden led Republican nominee Donald Trump 39.8% to 36.0% in June, Kamala Harris, now the official Democratic nominee for president, leads Trump 53.4% to 34.8% in the latest CPOR poll. Harris's lead over Trump, notably, is similar in size to the 18 percentage points by which Biden carried Bexar County in the [2020 presidential election](#).

The percentage of voters who stated they are currently unsure who they would vote for dropped from 15.3% in June to 10.0% in the latest poll, and the decision of independent candidate Robert F. Kennedy, Jr. (who polled at 4.9% in the June CPOR poll) to drop out the race and endorse Donald Trump does not appear to have boosted Trump's support among Bexar County voters.



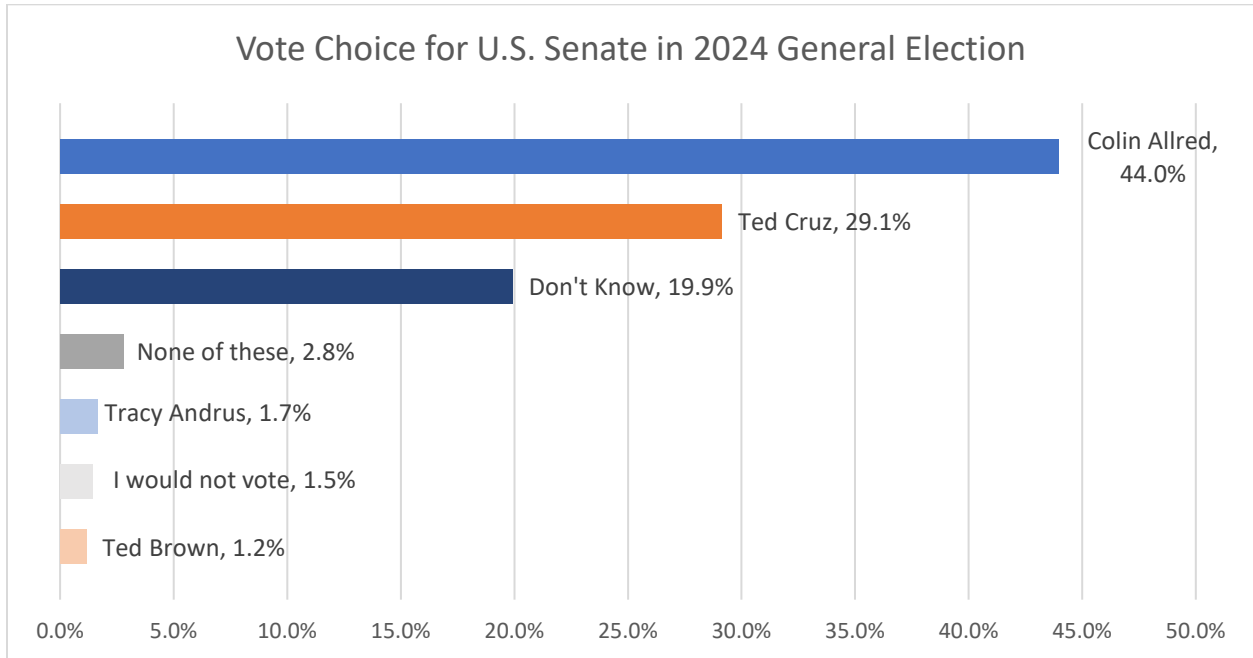

The poll also asked Bexar County voters about who they were likely to support in the U.S. Senate race in Texas this November. Again, there is evidence of a surge in Democratic support. Whereas Democratic challenger Colin Allred led incumbent Senator Ted Cruz 36.8% to 30.7% in the June poll, Allred now leads Cruz 44.0% to 29.1%. However, about 1 in 5 Bexar County voters (19.9%) remain undecided.

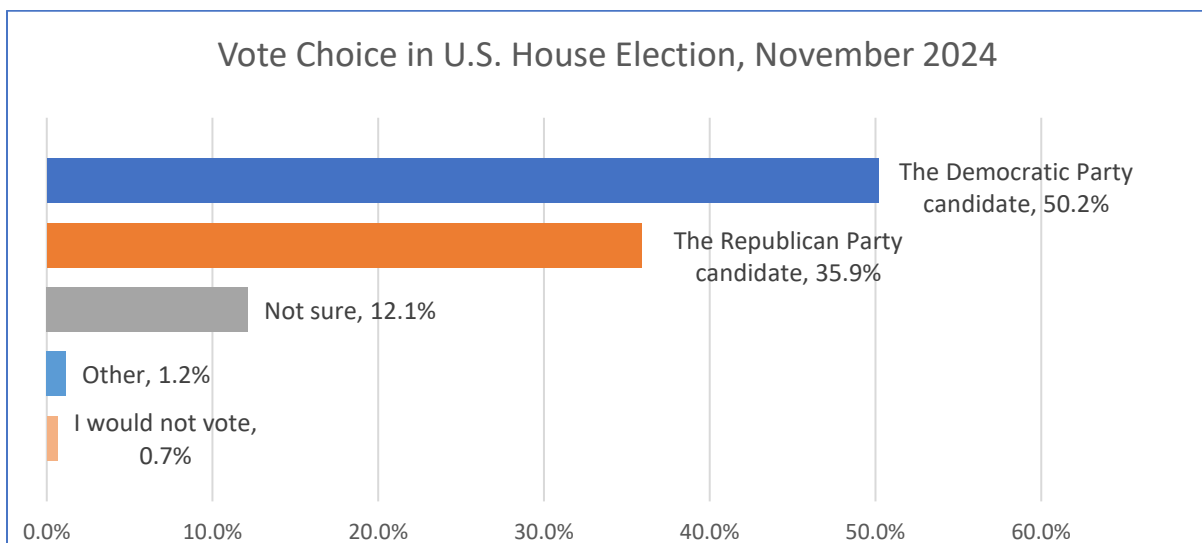

Bexar County voters were also asked about how they planned to vote in U.S. House races in November. Voters preferred Democrats over Republicans by 14.3 points, 50.2% to 35.9%--a notable increase from the 6.5 point Democratic lead (44.9% to 38.5%) in the June poll.

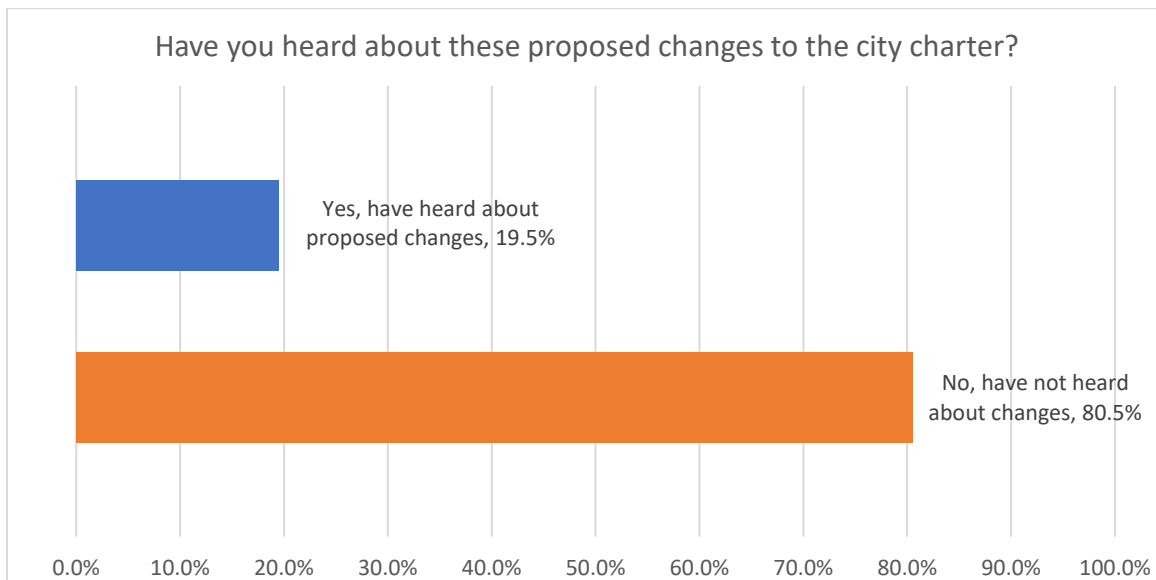

### Part 2. Support for Cty Charter Amendments and New Professional Sports Factes

San Antonio residents (n=620) were asked about their familiarity with proposed amendments to the city charter that were recently approved by the San Antonio City Council and which will appear on voters' ballots in the November election.

As was the case in CPOR's June poll, few voters were aware of the potential amendments; less than two in ten (19.5%) said they had heard about the proposed changes.

The poll also asked San Antonio residents (n=620) about their support for the six charter amendments that will appear on the ballot, providing brief descriptions of the amendments' effects. One of the recommended amendments would increase the baseline salaries for members of the City Council and the Mayor — \$70,200 for council members and \$87,800 for the mayor. Slightly more than a quarter (27.3%) said they would vote in favor of it, with a majority (50.7%) saying they would vote against it. A substantial number (22.0%) were unsure if they would support the amendment.

There was slightly more support for the amendment that would extend the terms of office for the mayor and members of the City Council from two years to four years: 42.7% said they would support it, with 43.8% opposed.

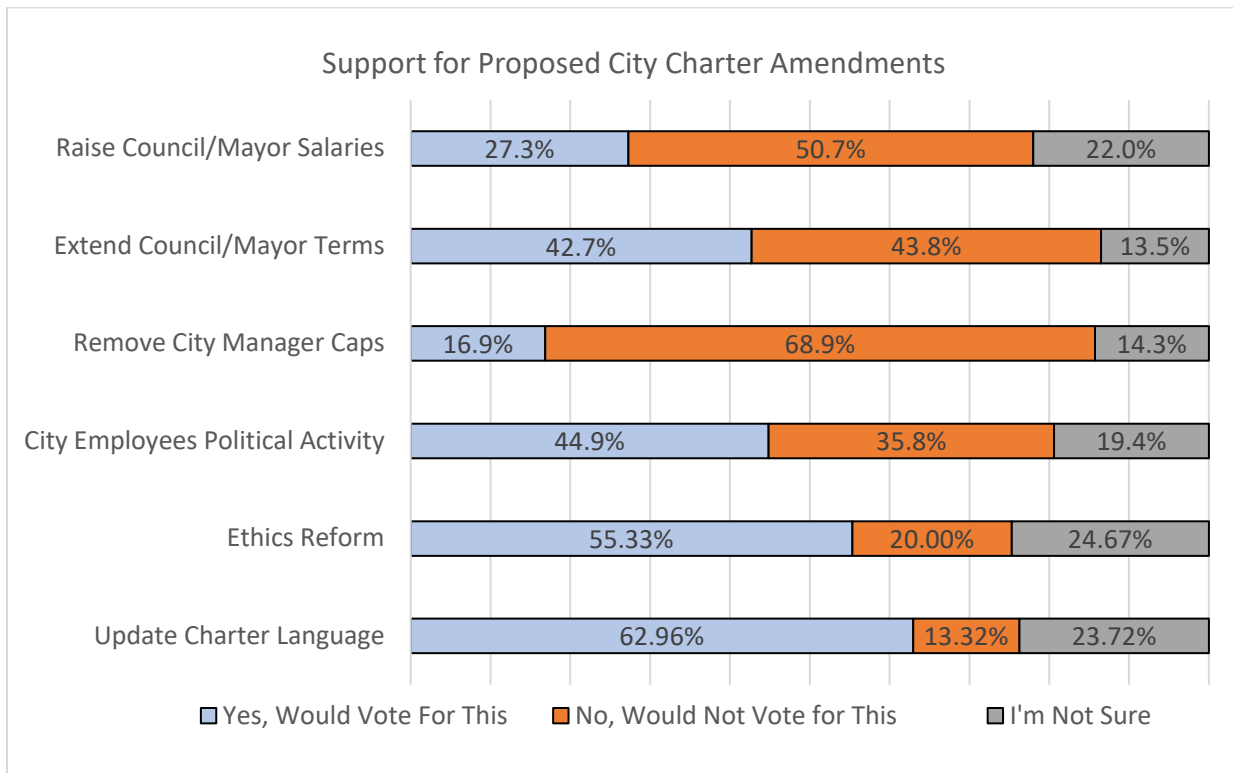
An amendment that would remove the cap on the salary of the city manager as well as the number of years a person could serve in that position garnered the least support. A super-majority (68.9%) said they would not vote for it, with only 16.9% in favor of the amendment.

A majority (55.33%) said they would support an amendment that would make minor changes to the city’s Ethics Review Board, making clear what qualifies as a “conflict of interest” and giving the board authority to take up or decline complaints that have already been heard by other offices. Only 1 in 5 said they were opposed to this. San Antonio voters indicated less support for an amendment that would allow city employees to participate in political activities such as block walking, working on municipal campaigns, and donating money to local candidates during their personal time (i.e., when not at work or in uniform). While 44.9% said they would support it, 19.4% remained undecided. Finally, a majority (62.9%) said they would support an amendment that would remove outdated terms and language in the charter.

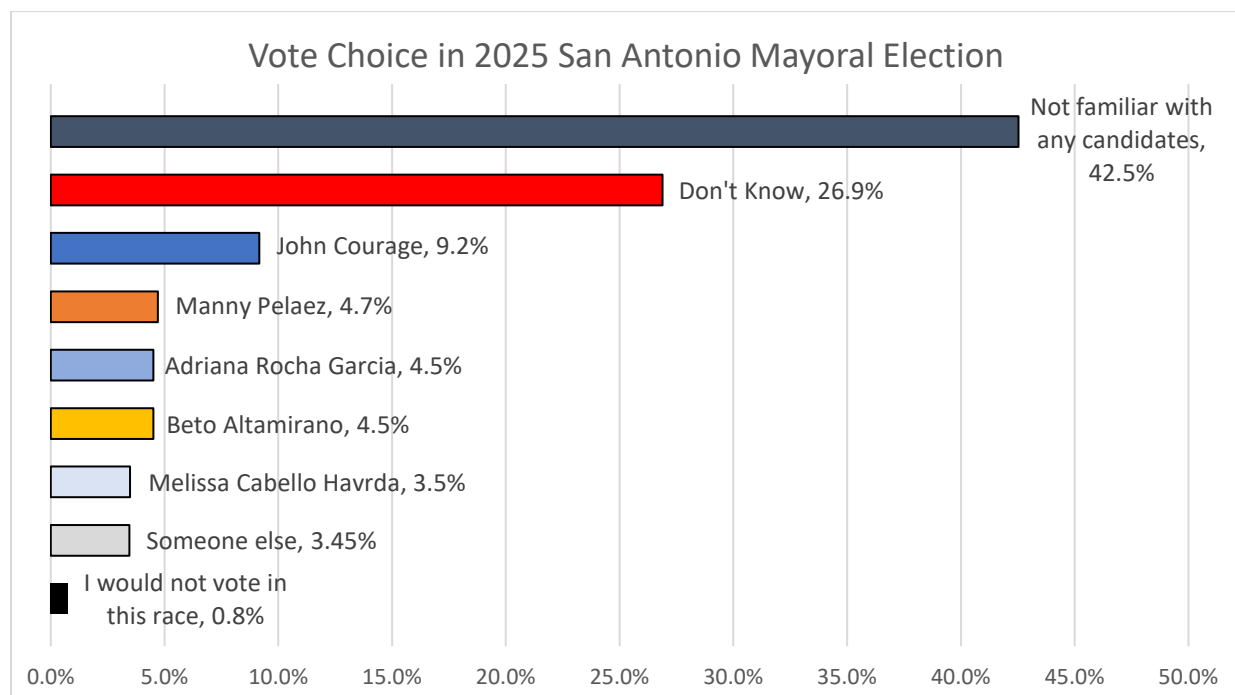

### Part 3. 2025 San Antonio Mayor's Race and New Professional Sports Facilities

San Antonio residents (n=620) were asked about their likelihood of voting in the May 2025 San Antonio municipal elections. Those who indicated they were at least somewhat likely to vote in May were asked about their choice for mayor among the five candidates who have declared their candidacy so far.

Few San Antonio voters have a clear choice for mayor, suggesting the race is wide open, with 42.5% stating they were not familiar with any of the candidates. Another 26.9% indicated they don't know how they would vote, and 3.45% said they would vote for someone other than the five declared candidates.

Of the individuals who have announced their candidacies for mayor, John Courage attracted the most support, with 9.2 percent. The other four candidates (Manny Pelaez, Adriana Rocha Garcia, Beto Altamirano, and Melissa Cabello Havrda) all polled at below 5%.

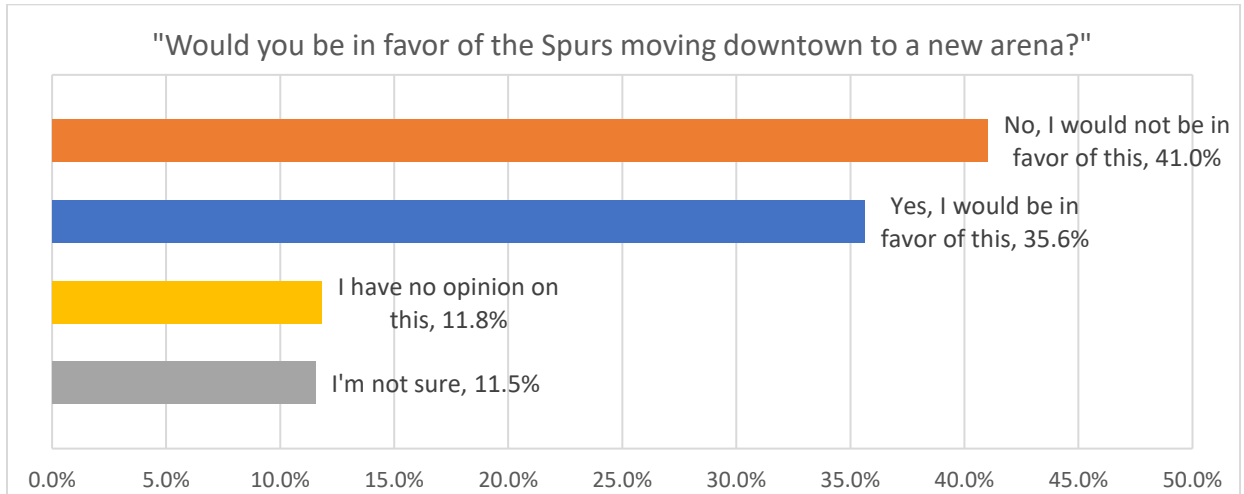

The September CPOR poll also asked Bexar County voters about potential plans made by the City of San Antonio and the San Antonio Spurs basketball team to build a new downtown arena for the Spurs in Hemisfair. Voters were asked if they would be in favor of the Spurs moving downtown to a new arena. As was the case in the June poll, there was relatively tepid support for the move. A plurality (41.0%) were opposed to the Spurs moving to a new arena, while 35.6% were supportive. About a quarter (23.3%) were unsure or had no opinion. While the September poll did not ask voters about the reason for their opposition to a new Spurs arena, [CPOR's June poll](#) found that finances and concern about the impact it would have on traffic/construction downtown contributed to opposition.

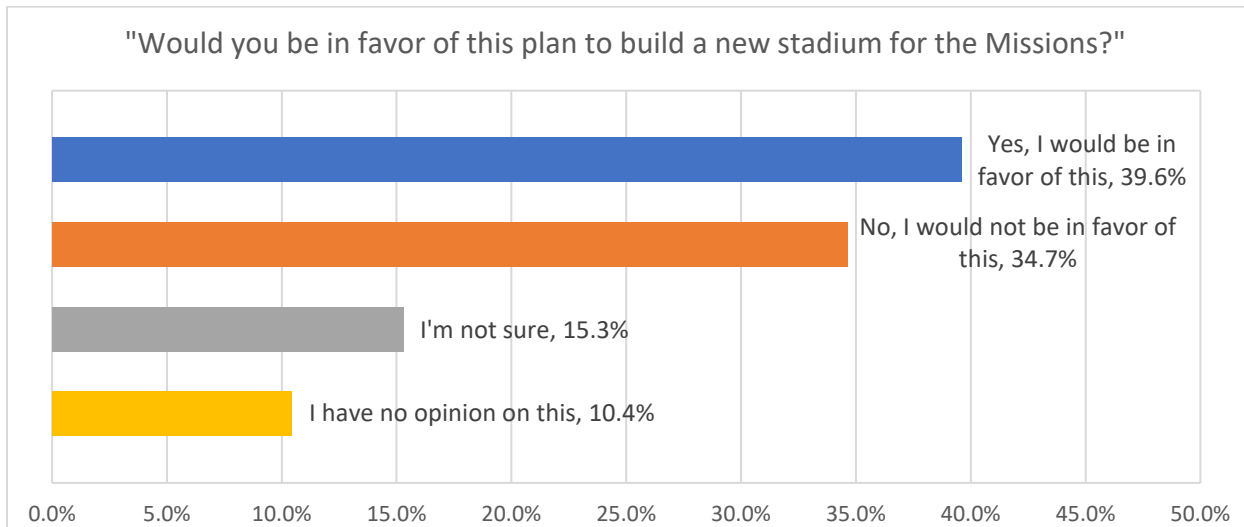

The September poll also asked about a plan proposed by the owners of the San Antonio Missions minor league baseball team to build a new 7,500-8,000 seat stadium just north of downtown San Antonio, with costs offset by nearby land development. Notably, the San Antonio City Council voted to approve the framework of the plan while this survey was in the field. As with the Spurs' new arena plan, voters were decidedly mixed about the Missions ballpark plan, with 39.6% supporting it, 34.7% not in favor of the plan, and more than quarter unsure or lacking an opinion.

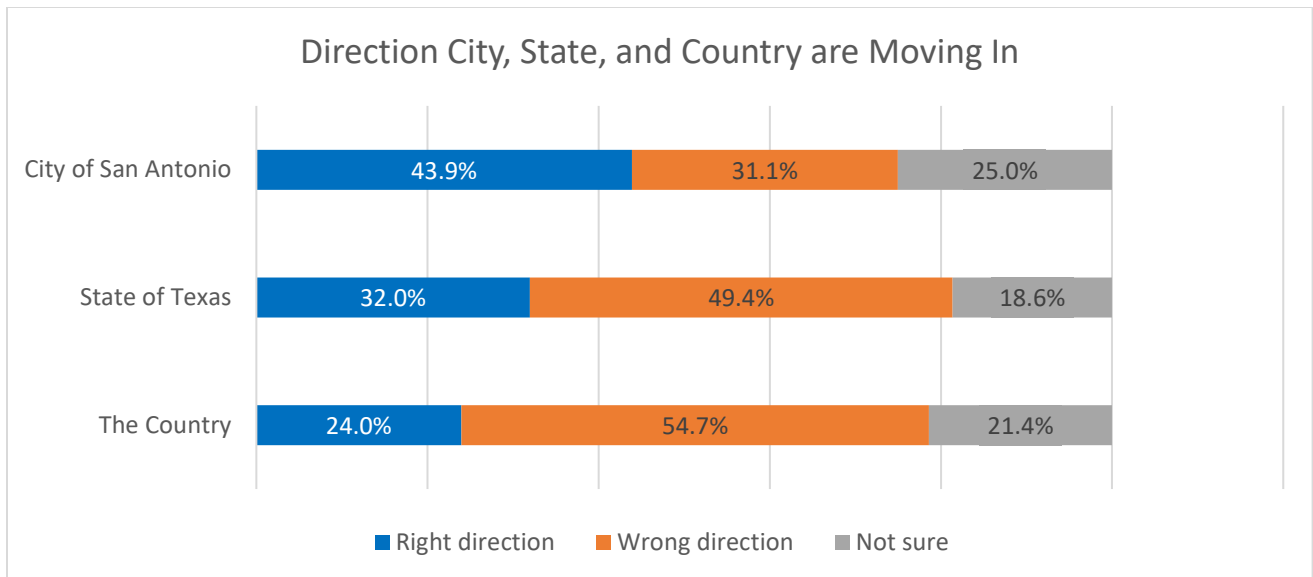
### Part 3. Evaluations of City, State, and National Government

#### *Direction City, State, and Country are Heading In*

Respondents were asked to assess the direction they thought the City of San Antonio, the State of Texas, and the country were headed in. As was the case in CPOR's [March](#) and [June polls](#), Bexar County voters were the most sanguine about the direction of the City the San Antonio: 43.9% selected "right direction" and 31.1% selected "wrong direction," with a quarter of respondents unsure.

Bexar County voters continue to be pessimistic about the direction the state and country were moving in. In the September poll, a majority (54.7%) still believed the country was moving in the wrong direction, and only 24% believed it was moving in the right direction. A quarter (25%) are unsure. However, this was a notable improvement from the June poll, when 67% thought the country was moving in the wrong direction and only 17.3% selected "right direction."

Views about the direction of the state did not change much. About 49.4% thought the state was moving in the wrong direction, similar to the 52.8% mark from the June poll. A bit less than a third continued to believe it was moving in the right direction.

#### **Trust in Government: National, State, and Local**

Respondents were asked how much of the time they thought they could trust the city government of San Antonio, the state government of Texas, and the federal government to do what is right. Bexar County voters again gave the highest marks to local government, with 44.1% believing they could trust

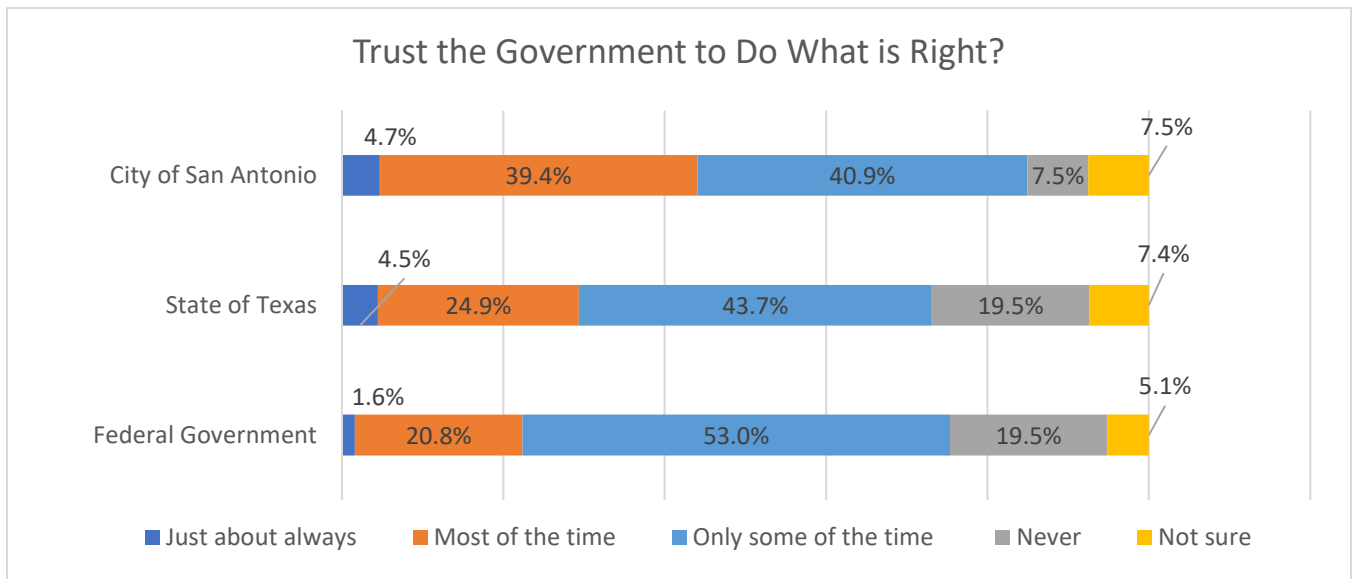

the government of the City of San Antonio to do the right thing just about always or most of the time. This number fell to 29.4% for the State of Texas and 22.4% for the federal government.

### **Approval of Local, State, and National Leaders**

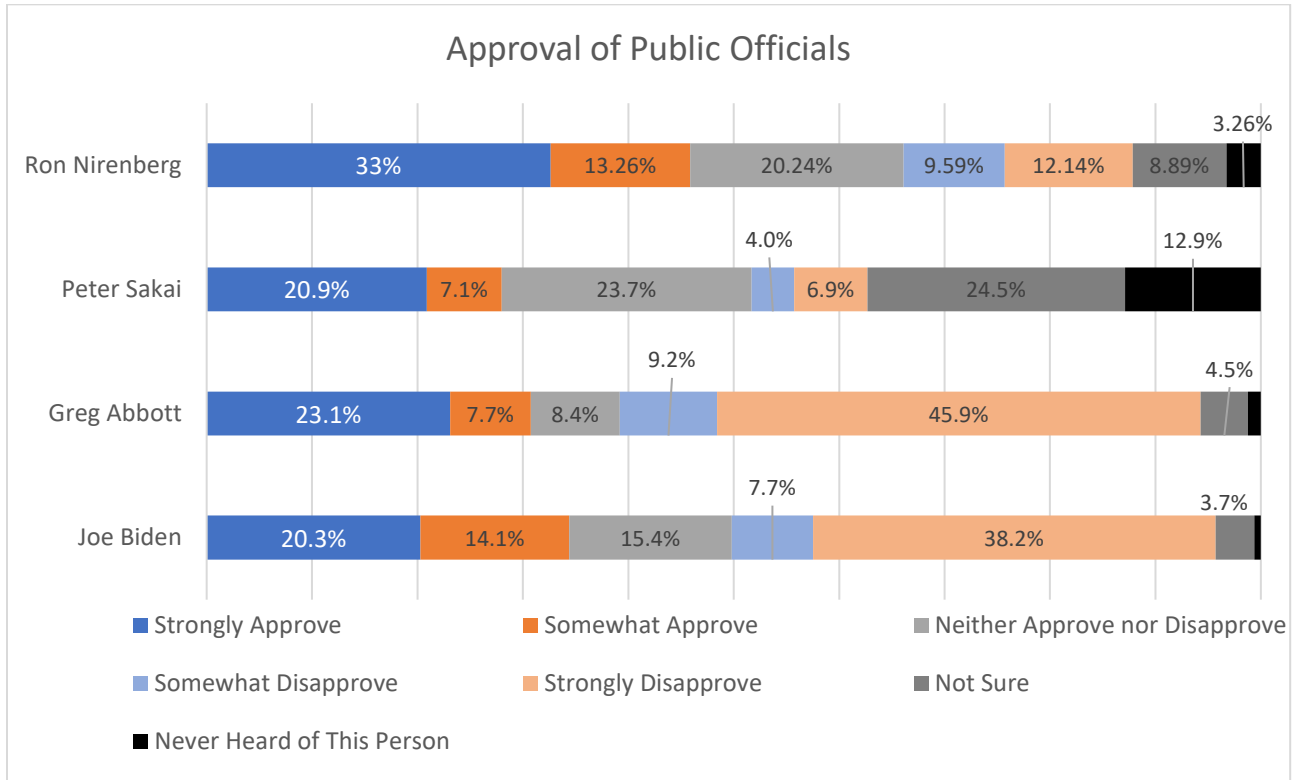
Higher marks for government at the local level extend to approval of public officials, as well. About 46% strongly approved or somewhat approved of the job Rob Nirenberg was doing as mayor of San Antonio, with 21.7% strongly or somewhat disapproving of his job performance. As was the case in CPOR’s previous two polls, familiarity with Peter Sakai, the Bexar County Judge, remains low: More than a third (37.3%) had never heard of Sakai or were not sure about his performance. A plurality approved of Sakai’s job performance (about 28%) while only about 11% disapproved.

Disapproval of both Governor Greg Abbott and President Joe Biden was much higher. More than half (55.1%) of respondents disapproved of Abbott’s performance as governor of Texas, with 30.8% approving. President Biden fared slightly better than Abbott, with 34.4% approving and 45.9% disapproving of his job performance. This was also a slight improvement from where Biden was in June before he dropped out of the presidential race, when 50.7% disapproved and 31.2% approved of his performance as president.

### **Part 4. Methodology**

#### ***Sample and Sampling Frame***

The sample consisted of voters in Bexar County, TX, constructed to approximate the likely November 2024 electorate. The sampling frame consisted of all registered voters in Bexar County, TX with verified email addresses. Information on registered voters, voter history, and their verified contact information came from a list purchased from the data broker, L2. The survey was fielded from September 11<sup>th</sup> to September 16<sup>th</sup>, 2024.

#### ***Sampling Methodology, Recruitment, and Weighting***

Summary answer: registered voters were randomly selected from three strata in proportion to how much of the electorate each stratum was expected to make up in the November 2024 election. This expectation was based on analysis of previous elections in Bexar County.

Detailed answer: Stratified registration-based sampling (RBS) was used to select the sample. Bexar County registered voters with verified email addresses were stratified into three categories, based on personal vote history in presidential general elections: voters, abstainers, and new registrants with no vote history. Estimates of the rates at which each of the three strata were expected to vote in the November 2024 general election were then produced based on an analysis of previous presidential general elections: the rates at which 2016 voters, abstainers, and new registrants voted in the 2020 elections were calculated, as were the rates for these groups in 2012 for the 2016 election. The average of the 2016 and 2020 rates, via turnout records included in the commercial voter file, was used as the benchmark voting rates for 2024. The number of voters in each stratum were then multiplied by the estimated voting rates to produce the fraction of the sample each stratum should make up.<sup>1</sup> After the survey was fielded, data were weighted by these strata fractions.

#### ***Mode and Language***

Respondents were recruited via email, which provided a link to the survey, hosted on the computer-assisted self-interviewing platform, Qualtrics. Reminder emails were sent out to subjects who had not completed the survey several days after the initial recruitment email was sent out. The survey was bilingual. Respondents were given the option to complete the survey in either English or Spanish.

#### ***Sample Size, Sampling Error, and Response Rate***

69,767 voters were randomly selected in total for participation in the poll. 945 individuals began the survey, with 692 respondents completing the survey. The response rate was approximately 1%, and the completion rate was 75%. The (unadjusted) margin of error for the poll was +/- 3.7%.

### ***Data Processing and Quality***

Bots, fraudulent responses, and multiple submissions were prevented via tools included on the survey platform Qualtrics. Human coders were used to assess open-ended responses. Surveys completed in less than two minutes were to be flagged for straightlining, but no surveys in this poll violated the two-minute rule.

### ***Acknowledgement of Limitations***

As with all research, this poll has limitations, and we acknowledge the unmeasured error associated with all forms of public opinion research.
