

# LIMITED SUPPORT FOR SPURS ARENA PROPOSITION (PROP B) AMONG VOTERS, MODERATE SUPPORT FOR RODEO EXPANSION (PROP A) AND PROJECT MARVEL OVERALL

FIRST GINA ORTIZ JONES APPROVAL NUMBERS INDICATE THE PUBLIC IS STILL GETTING
ACQUAINTED WITH MAYOR

RESULTS FROM BEXAR COUNTY LIKELY VOTER POLL—OCTOBER 1-3, 2025

**SAN ANTONIO, TX** – A poll of Bexar County likely voters (n=660, MOE= +/- 3.8%) conducted by the UTSA Center for Public Opinion Research shows limited support for two November ballot propositions associated with Project Marvel. Prop B, which would raise the county's venue tax and designate funds for the construction of a new stadium for the San Antonio Spurs, drew support from about 4 in 10 voters. A plurality (46%) said they planned to vote against Prop B. About 44% of voters said they planned to vote for Prop A, which would raise and designate venue tax funds for an expansion of the San Antonio Stock Show and Rodeo grounds. Roughly 1 in 7 said they were not sure how they would vote for each proposition. Similar to Prop A's support, 45% of voters voiced support for Project Marvel in general, with 40% believing the city should not move forward with the plan to redevelop Hemisfair (**Part 1**).


The first approval ratings for Mayor Gina Ortiz Jones since she took office in June 2025 indicate that voters are still familiarizing themselves with the mayor. About 25% approved of her job performance, 26% disapproved, and about half were unsure or chose a neutral position. Bexar County Judge Peter Sakai drew more approval than disapproval, and Governor Greg Abbott and President Donald Trump both had high disapproval rates among Bexar County voters. Voters gave relatively high marks to local government, but there were signs of pessimism. Although significantly more voters believe the City of San Antonio is headed in the right direction compared to the state or the country, 30% think the city is on the wrong track (Part 2).

The study's methodology is included in **Part 3**, and sample demographics, cross tabulations, and question wording are included in the appendix.



### Part 1. November General Election, Ballot Propositions, and Support for Project Marvel

The November 2025 election will feature two ballot measures linked to Project Marvel, a plan to redevelop a portion of Hemisfair in downtown San Antonio into a sports and entertainment district, including a new downtown arena for the San Antonio Spurs. Bexar County likely voters were asked how much thought they had given to the November joint election in which local voters would be voting on several ballot measures and constitutional amendment. A majority—about 62%—indicated they had given a lot or quite a lot of thought to the election. A small percentage (5%) indicated they had given no thought at all.


As part of the Project Marvel plan, some of the funding for the new San Antonio Spurs arena could come from Bexar County's venue tax, which is a tax on rental cars and hotel rooms. In November, Bexar County voters will be asked to approve two ballot measures that will raise and extend the venue tax and designate venue tax funds for the expansion of San Antonio Stock Show and Rodeo grounds (including the redevelopment of the Spurs' current arena) and the construction of a new Spurs arena in Hemisfair.

Likely voters were asked about their overall support for Project Marvel, as well as whether they plan to vote for or against two ballot propositions: Prop A (the Stock Show and Rodeo proposition) and Prob B (the Spurs arena proposition). Voters were shown the full wording of both venue tax propositions and



asked how they planned to vote on both. The ordering of the questions (Project Marvel or the ballot propositions) was randomized.


A plurality of voters (44%) said they planned to vote for Prop A (venue tax funding for the Stock Show and Rodeo grounds expansion). Another 41% said they would vote against it, and 15% said they were unsure how they would vote. Support for Prop B (venue tax funding for a new Spurs arena) was lower, with 40% saying they would vote for the proposition, 46% saying they would vote against it, and 14% unsure. However, the difference in support for Prop A and B was not significant at conventional levels.

Support for Project Marvel overall was similar to that of Prop A, with a plurality of voters (45%) saying they think the city should move forward with the project, including construction of a new arena for the San Antonio Spurs, a land bridge over Interstate 37, and expansions of the Henry B. Gonzalez Convention Center and the Alamodome. About 40% were opposed to the city moving forward with the plan, with about 13% unsure and 2% with no opinion.






#### Part 2. Evaluations of City, State, and National Government

### Direction City, State, and Country are Heading In

Voters assessed the direction they thought the City of San Antonio, the State of Texas, and the country were headed in. A plurality of voters (39%) thought the City of San Antonio was moving in the "right direction," with 30% selecting "wrong direction," and another 31% unsure. Majorities believed the state (62%) and country (66%) were moving in the wrong direction. The percentage of voters who thought the state (29%) and country (28%) were moving in the right direction were similar.






### Trust in Government: National, State, and Local

Less than half of voters (45%) trust the government of the City of San Antonio to do the right thing just about always (4%) or most of the time (41%). Far fewer said the same for the State of Texas (26%) and the federal government (17%). While only 6% said they thought they could never trust local government to do what is right, a quarter (25%) indicated that the state government could never be trusted, and more than 4 in 10 local voters (42%) said the federal government could never be trusted.






#### Approval of Local, State, and National Leaders

Less than four months into her tenure as Mayor of San Antonio, it is clear voters are still getting to know Gina Ortiz Jones. About 30% report they neither disapprove or approve of her performance as mayor, and another 17% say they are not sure (similar proportions say the same when the sample is restricted to just San Antonio voters). About a quarter (25%) somewhat approve or strongly approve of Jones' job performance, with 26% somewhat or strongly disapproving (these numbers are 25% and 28%, respectively, among San Antonio voters).

More than a third of voters (37%) approved of Peter Sakai's performance as the Bexar County Judge, while 24% said they neither approved nor disapproved. About 1 in 5 (20%) were not sure, and another 10% indicated they had never heard of Sakai. Only 10% said they disapproved of Sakai's performance.

Disapproval of both Governor Greg Abbott and President Donald Trump was high. More than half (64%) of voters voiced disapproval of Abbott's performance as governor of Texas, with 58% strongly disapproving. About 29% approved of Abbott's job performance. A similar percentage (28%) approved of Donald Trump's performance as president. About two-thirds (66%) disapproved of Trump with 4% somewhat disapproving and 62% strongly disapproving of his job performance.





Part 3. Methodology

#### Sample and Sampling Frame

The sample consisted of likely voters residing in Bexar County, TX. The sampling frame consisted of all registered voters with Bexar County residential addresses and verified email addresses. Information on registered voters, voter history, and their verified contact information came from a list purchased from the data broker, L2. Respondents who did not consent to participate, indicated that they did not live in Bexar County, or indicated they were not likely to vote at all in the November 2025 joint election were excluded. The survey was fielded from October 1st to October 3rd, 2025.

## Sampling Methodology, Recruitment, and Weighting

Stratified registration-based sampling (RBS) was used to select the sample. Registered voters with verified email addresses were stratified into three categories, based on personal vote history in prior November joint elections: voters, abstainers, and new registrants with no vote history. Estimates of the



rates at which each of the three strata were expected to vote in the November 2025 election were then produced based on an analysis of previous odd-year November joint elections. Weighted average turnout rates for each of the groups were then used as the benchmark voting rates for the November 2025 election. The number of registered voters in each stratum was then multiplied by the estimated voting rates to produce the fraction of the sample each stratum should make up. After the survey was fielded, data were weighted by these strata fractions and self-reported likelihood of voting.

#### **Mode and Language**

Respondents were recruited via email, which provided a link to the survey hosted on the computer-assisted self-interviewing platform, Qualtrics. Reminder emails were sent out to subjects who had not completed the survey several days after the initial recruitment email was sent out. The survey was bilingual. Respondents were given the option to complete the survey in either English or Spanish.

#### Sample Size, Sampling Error, and Response Rates

The samples consisted of 660 likely voters. Approximately 70,000 voters were randomly selected in total for participation in the poll. The response rate was approximately 1%. The (unadjusted) margin of error for the poll was +/- 3.8%.

#### **Data Processing and Quality**

Bots, fraudulent responses, and multiple submissions were prevented via tools included on the survey platform Qualtrics. Surveys completed in less than two minutes were flagged for straightlining, but no surveys in this poll violated the two-minute rule.

#### **Acknowledgement of Limitations**

As with all research, this poll has limitations, and we acknowledge the unmeasured error associated with all forms of public opinion research.
